**Summary of the Santa Cruz Board of Supervisors
Deliberate destruction of Due Process
Ellen Pirie Asked to Resign**

About 2001 ... **Ellen Pirie** appointed a person to a "**mandated appeals board**". This board was never intended to meet. It was to be a "ghost board" with *phantom members*. This was to be form over justice. The other Santa Cruz Supervisors appointed other "no shows".

In fact the *ghost board* has never met in almost 7 years except *illegally* in **violation** of the open meeting laws and the Brown Act.

Every supervisor here is an attorney, **professional real estate investor** or associated with the **ACLU**.

No claim of ignorance can be made.

To compound your guilt ... everyone of you have failed to instruct the CAO to protect and secure the planning department records from alteration and destruction. **You can't be this deaf, dumb and blind.**

You have thrown out *due process* and the American system of check and balances.

You are implementing an alien Fascist agenda .. **Agenda 21**

Your **UN plan of regional governance** has willfully and maliciously stripped the people of Santa Cruz of their civil and property rights.

You are not supposed to be **imposing ... the program** of the **UN Association** (USA) (headed by William H. Luers, Council on Foreign Relations) ... on **we the people** ...

We never voted for that. And ... Unlike you **we did not surrender** our Constitution.

Like pedophiles ... you kept the **people's appeals board** ... locked in the basement.

The **nepotism** and **conflicts of interest** and **violation of people rights** ... ***is intolerable***.

Ellen Pirie you are being asked to resign by next Monday. Or the civil rights division in San Francisco of **Justice Department** will be requested to take immediate action.

The supervisors are being asked again ...to secure the records of teh Planning Department. The hard working employees in that department are also expecting you to "**clean up the illegalities**" ... which would mean firing Tom Burns.
