July 29, 2008, Santa Cruz - Has there been on going "Conspiracy" to deny the ***civil and property rights*** of the people of the county of Santa Cruz California by it's Planning Department?

**Has the Santa Cruz County** planning Department been operating covertly behind the scenes? Has it *criminally* denied access to the **Building Board of Appeals?** ... Is it denying the citizens of the county ... both their property and civil rights?
