

SUPERVISOR PIRIE AND DIRECTOR BURNS SHAMED FOR WRONG DOINGS. PIRIE RECALL EXPLORATORY COMMITTEE ANNOUNCED.

August 19, 2008 – At today’s Board of Supervisors public meeting, a new activist stood up to reveal hidden practices of the planning department against citizens. Currently on leave, County planning employee **Vince La Franco**, former code compliance officer and 20 year contractor, statements were very revealing and will be posted accurately shortly.

G. Richard Arnold, of the Association of Real Estate Advisors, again stood up exposing Supervisor and planning dept. violations of property rights, constitutional rights and due process for Santa Cruz County citizens. Today he announced (**read his statement**) the astonishing exposure of finding Chair Supervisor, **Ellen Pirie**, appointing (**see letter**) her husband, Terry Hancock, to the Planning Commission! It may not be illegal to share the bedroom but wouldn’t you think that since both are lawyers that they would know the difference of right from wrong and the obvious shear conflict of interest here? Property owners have to apply to the Planning Commission and many are denied. The few who pass are then fed upstream to the Board of Supervisors for approval.

Arnold goes on to announce, “I have been authorized by people who have contacted me to announce that an **Exploratory RECALL Committee** will meet in **Ellen Pirie’s** district.”

Jan Beautz, Supervisor for four terms too long, is stepping down after her biggest embarrassment and breach of citizens’ rights. Insiders say Beautz has participated in and allowed the overreaching placement of approximately 72 unfounded red tags on a Soquel property owner. Extreme is not the word for this – personal vengeance or tyranny are more appropriate.

What about the behind closed doors, secret memos and secret phone conference calls with Tom Burns, the Director of the Planning Department; many believe are currently being destroyed? County Counsel doesn’t understand the laws that protect property owners, contractors and the people of this County and, in our opinion, are misadvising with false assumptions and ignorance that perpetuates itself. Their practices, experienced by tens of thousands of citizens, are stated as being “dictatorial and tyrannical no matter the cost to the individual”. Shouldn’t this unreasonable and disrespectful behavior be stopped and property owners refunded in full? **Are the members of this inside club subject to the U.S. Code Title 18 Part I Crimes Chapter 13 – Civil Rights Section 241: “Conspiracy against rights” and Section 242: “Deprivation of rights under the color of law?”** These are punishable by fines and imprisonment for any terms of years or for life!

What about the head of all of this – Susan Mauriello, the enforcing County Administrator for supporting interests other than your rights? Why is she paid more than the Vice President of the United States? Are you getting it now? Mauriello, Pirie and Burns will be asked to resign; they should know better to quit yesterday.

Slowly Arnold, and the local activists group, the Alliance for Change, are finding a solid history of well planned manipulation for government control over you, your rights, for your money and property. It is important to know your rights and what has been going on around you. This history is being tied together on our website week to week and solid proof of instituted patterns against you and all of us is coming into view. A previous Grand Jury report covered this before and will soon be asked to do it again.

The courts have multiple suits to rule for what is right this time around and constitutional rights are generally upheld, especially with so much overwhelming evidence and on the record statements which we have copies of. Thank you activists for standing up!
