

**California Government Code Establishes the Board of Supervisors.  
It is mandatory for BOS to respect State higher laws.**

**Read Government Codes that hold Supervisors for neglect to perform duties or if they violate any law or fraudulently or corruptly performs any duty.**

**25022 - Special meeting can be called for official misconduct**

25042. Any supervisor who (a) refuses or neglects to perform any duty imposed on him, without just cause, or (b) willfully violates any law provided for his government as a supervisor, or (c) fraudulently or corruptly performs any duty imposed on him, or (d) willfully, fraudulently, or corruptly attempts to perform an act as supervisor which is unauthorized by law, in addition to any other penalty prescribed by law, forfeits to the county five hundred dollars (\$500) for every such act, to be recovered on his official bond, and is further liable on his official bond to any person injured thereby for all damages sustained.

25170 – Tom Burns could be subpoenaed and his records must be produced before the BOS at a public special hearing for alleged misconduct and violations.

25170. Whenever the board of supervisors deems it necessary or important to examine any person as a witness upon any subject or matter within the jurisdiction of the board, or to examine any officer of the county in relation to the discharge of his official duties as to the receipt or disposition by him of any money, or concerning the possession or disbursement by him of any property belonging to the county, or to use, inspect, or examine any books, account, voucher, or document in the possession or under the control of the person or officer relating to the affairs or interests of the county, the chairman of the board shall issue a subpoena, in proper form, commanding the person or officer to appear before it, at a time and place therein specified, to be examined as a witness. The subpoena may require the person or officer to produce all books, papers, and documents in his possession or under his control, relating to the affairs or interests of the county.
