

STRAIGHT TALK NEWS "APPEALGATE" REPORTING IS ACCURATE.

August 22, 2008 - After being accused of inaccurate reporting, we reviewed the DVD of the Board of Supervisors August 19, 2008, meeting. Turns out our reporting was spot on. To read the full transcript of Vince LoFranco's protest speech stating that Burns should be removed along with his management team and that documents are being destroyed - read more. In addition, Dana McRae, County Counsel (State Bar #142331) attending the meeting, in our opinion, again has misdirected the Supervisors and Planning Directors with her Appealgate statement, ". . . and then there is due process in the code compliance arena".

To clarify what the County is up to we have been told that Tom Burns made similar statements on August 12, 2008, that red tagged properties are handled differently and county counsel has advised him so; meaning the Appeal Gates are closed to red tagged properties. The actual law is that ALL AND ANY CITIZEN FOR ANY REASON is allowed an independent, separation of power, citizen appointed appeal committee, board or other authorized by State Code due process - to hear ALL hearings and ALL appeals requested- by any citizen who asks (for any reason or cause) and without a TIME limitation to make a request for the hearing or appeal. Citizens are NOT to be censored or filtered through an adversarial government or obstructed from due process in a contained administrative controlled hearing. See State Code 108.8. Citizens are not to be turned away after 14 days to appeal. Again, there is no time limit to appeal. This is an illegal practice that will soon come to an end and has been used against innocent citizens and property owners for more than a decade. These laws have been broken, breached and violated for thousands and thousands of homeowners and commercial property owners and the orders come from the top down as the County does not have legal standing to even serve red tags. We don't understand why County Counsel, the Supervisors, the Planning Dept. and Code Compliance section are operating under such extreme false assumptions that force the public to sue for proper due process. Protests have been made in speeches and in letters for a very long time and this local government is not yet listening or realizing what they have done!

The wronged will be coming forward for restitution and recourse of hundreds of millions of dollars and land taking returns. They will be asking for Tom Burns and his management team to step down and to recall Ellen Pirie, Chair Supervisor, who is allowing this form of revenue mistreatment to take place and continue per personal experiences communicated. Even if the County has or will destroy documents, it will not make any difference, as documents have already been copied and in the proper hands. It is too late for those who have disobeyed the

Constitutions and statutes that they gave their oath to uphold, including the weekly Pledge of Allegiance that ends with the words, "for liberty and justice for all".
